Under the Noise Pollution (Regulation and Control) Rules 2000, the unit holder shall take adequate measures for control of noise from its own sources within the premises so as to maintain ambient air quality standards in respect of noise to less than 75dB(A) during day time and 70 dB(A) during night time. Daytime is reckoned in between 6 am to 10 pm and night time is 10 pm to 6 am
- 7. The Hospital authority shall comply to the Plastic Waste Management Rules 2016 dated 18-3-2016
- 8. Self Monitoring Schedule :

The HCF shall have to get the samples of emission/Effluents analysed from the laboratory of J&K PCC or laboratories approved by J&K PCC to the check the efficacy of Pollution Control Devices (PCDs) installed in the unit

- 9. The Hospital authority shall comply with the additional conditions as stipulated below:-
- i. The Consent is valid for the Establish of Hospital only. Any change are upgraded the HCF, shall have to be intimated to the JKPCC. For any enhancement of the above, fresh consent has to be obtained from J & K Pollution Control Committee.
- ii. The Hospital authority has to keep a record of the environmental data monitored regularly with regard to operation and maintenance of pollution control devices viz Air Pollution and Water Pollution Control to achieve the desired standards notified in EP Act.

Pollution Control Devices (ETP/ECD) as contemplated to achieve the quality of effluent emission within the tolerance limits prescribed, shall have to be operational during the course of production. The effluent/emission shall not contain constituents in excess of the tolerance limits as laid down by J & K Pollution Control Comparitee.

- iv. The Hospital authority shall be liable to pay compensation in case any damage is caused to the environment.
- The Hospital authority shall abide by the directions of the Committee which will be issued from time to V. time. Any infringement/ violation or trangression of the statutory enactments of pollution control acts by the unit, shall be sufficient cause to prosecute the violator in conformity with relevant section of Air/Water Acts and Environment Protection Act in force.
- The Hospital authority be under surveillance monitoring of J & K Pollution Control Committee vi.
- The Hospital authority shall provide adequate arrangement for fighting the accidental leakages/discharge of vii any air pollutant/gas/liquid from the vessel, machinery etc. which are likely to cause fire hazard including environmental pollution.
- viii. The Hospital authority shall adhere to general standards terms and conditions of Water / Air Acts and compliance of environment standards as per environment protection act 1986
- The Hospital authority should apply 60 days in advance for renewal of consent before expiry the date of this ix. Consent Order.

#### **Specific Conditions:-**

- The Hospital Management has to operate all requisite pollution control devices in the Hospital as envisaged 1. under Bio-Medical Waste Management & Handling Rules.
- The Hospital Management shall adhere to general terms and conditions of Water (Prevention and Control of 2. Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and ensure compliance of environment standards as per EP Act 1986 and as amendments made thereof. The Hospital Management shall handover the waste generated to CBMWTSDF.

- The Hospital Management shall install Colour coding bins with proper labelling in the hospital. Segregation 4. of waste must be done at sources.
- 5. The Hospital Management shall make the web site portal of BMW.
- The Hospital Management shall install the ETP and maintain the log book of ETP along with log book of 6. Bio-Medical Waste (BMW) generation
- Periodic Inspection by Divisional Officer, PCC as per schedule for Orange category units. 7.
- The Hospital Management shall remain under surveillance of the JKPCC regularly. 8.


